For each visitor to our website, our web server automatically recognizes only the visitor's domain name, but not the e-mail address. We collect only the domain name, but not the e-mail address of visitors to our website; the e-mail addresses of those who communicate with us via e-mail; aggregate information on what pages consumers access or visit; and information volunteered by the consumer such as survey information and/or site registrations, name and address, telephone number, fax number, payment information (e.g., credit card number and billing address).

The information we collect is used to improve the content of our website, used to notify consumers about updates to our website, and used by us to contact consumers for marketing purposes.

We do not share our customers' information with other organizations or businesses, **ever**.

If you supply us with your postal address you may receive periodic mailings from us with information on new products and services or upcoming events. If you do not wish to receive such mailings, please let us know by calling us at the number provided above, e-mailing us at the above address, or writing to us at the above address.

Persons who supply us with their telephone numbers will only receive telephone contact from us with requested information.

With respect to Ad Servers: We do not partner with or have special relationships with any ad server companies.

From time to time, we may use customer information for new, unanticipated uses not previously disclosed in our privacy notice. If our information practices change at some time in the future we will post the policy changes on our website to notify you of these changes and provide you with the ability to opt out of these new uses. If you are concerned about how your information is used, you should check back at our website periodically.

Customers may prevent their information from being used for purposes other than those for which it was originally collected by e-mailing us at the above address, calling us at the above telephone number, or writing to us at the above address.

Upon request we provide site visitors with access to all information [including proprietary information] that we maintain about them - financial information (e.g., credit card account information) if applicable, unique identifier information (e.g., customer number or password), transaction information (e.g., dates on which customers made purchases, amounts and types of purchases), communications that the consumer/visitor has directed to our site (e.g., e-mails, customer
